UNDERGRADUATE STATEMENT OF UNDERSTANDING, 2017-2018

Read the following statements carefully. If you agree to follow these guidelines and wish to be considered for admission please sign below.

- 1. I understand that I must comply with all admission requirements and academic policies at Oklahoma Christian University.
- 2. I understand that I must provide financial documentation that I, my parents, or my sponsor have funds available for the cost of one year of undergraduate studies. I can find the I-20 costs on the Undergraduate Financial Worksheet.
- 3. I understand that I must pay all costs on my student account on or before the first day of each semester and that I will not be allowed to enroll for the next semester until my student account is paid in full. I also understand that if tuition fees increase while I am attending Oklahoma Christian University, I must pay the increased amount of tuition fees for each semester that follows.
- 4. I understand that admitted applicants must pay a minimum \$3,500 enrollment deposit to enroll in classes, reserve housing, & register for required student orientation.
- 5. I understand that I will be billed for required OC student health insurance. I will be billed for an entire year (August to August) each fall.
- 6. I understand that I will be charged a one-time \$150 fee for new student orienation, a \$25 activity fee each semester, and a graduation fee of \$100 the last semester of my degree program.
- 7. I understand that I must attend the orientation for new international students, Take Flight, and Earn Your Wings.
- 8. I understand that submitting SAT or ACT scores is not an admission requirement for international students. However, it is strongly recommended that I submit one of them for course placement and for awarding of Academic Scholarships. I also understand that taking the ACT at OC will be my own expense. I understand that the International Student Scholarship cannot be combined with an Academic Scholarship.
- 9. I understand that students under the age of 23 or with less than 124 credit hours must live in on-campus housing and purchase an Oklahoma Christian University meal plan through the university cafeteria.
- 10. I understand that OC residence halls may be available during the winter break at my expense, and that OC apartment housing may be available during the summer break at my expense.
- 11. I understand that I am required to report a tuberculosis skin test and immunizations upon arrival. I should bring documented proof of required immunizations. The cost for any needed immunizations is my responsibility.
- 12. I understand that the possession and use of tobacco on campus, and the possession and use of drugs and alcohol anywhere while I am a student at OC, are strictly forbidden and that I may be dismissed from the Oklahoma Christian University for violating these rules.
- 13. I understand that if am required to attend chapel events, which include prayer times, volunteering opportunities, cultural events, and special speakers.
- 14. I understand that I am required to take a minimum of 16 credit hours of textual Bible courses (at least one course each semester).
- 15. I understand that as a student with an F-1 visa I can work up to 20 hours in an on-campus job and that I cannot work off campus without being eligible for and filing for special permission from the U.S. Citizenship and Immigration Services (USCIS) through the Office of International Programs.
- 16. I understand that as a student with an F-1 visa I am required to file a tax form each year I am a student at OC and that I must report eligible scholarship money, income, and wages earned in the U.S. during that year.
- 17. I understand that I must remain enrolled in a full course of study each semester in (at least 12 credit hours) to be in good standing with the U.S. Immigration and Naturalization Service. Failure to do so will result in a violation of my F-1 Student visa.
